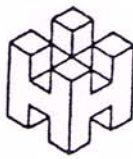

M/s Space Age Concepts (I) Ltd. has supplied and installed 4 Nos. Magnetic Water Conditioners Model SW 100 on our cold storage condensor system containing 10 Nos. Cold Storages and 3 Nos deep freezers in August, 1999. The magnetic water conditioner were installed on 100 mm dia copper pipe by replacing old MS pipe of 100 mm dia for the required portion.

No chemical descaling has been carried out on the system during the last two years. The Condensor tubes were physically checked in July, 2000 at a couple of different locations and no scale was observed inside the tubes. Earlier scale formation was found removed. The performance of the condensers is found improved after installation of the Magnetic water conditioners.

Sir,


With reference to the above subject, it is stated that Space Age a supplier of magnetic fluid conditioner device has approached for inclusion of these conditioners as a optional item in drip sets.

The proposal has been discussed in our State Level Committee. Magnetic water conditioners affect the carbonates and bicarbonates and other soluble salt molecules like calcium and magnesium. As unconditioned water passes through a properly designed magnetic conditioning device the principle of magnetic resonance causes the rupturing of breaking apart of clusters of water molecules. It is known that conditioned water can take crystallized calcium carbonate back into solution conditioned water also more easily dissolve other minerals such as magnesium, nitrogen, phosphorous, potassium, etc. which are needed for plant growth. It is mainly helpful for avoiding clogging in drippers, as the complexes of CaCO_3 , MgCO_3 never get formed. The technical booklet is attached herewith.

You are therefore requested that above mentioned device may be considered as a optional item in drip set. The copy of I.I.T. report is enclosed herewith.

Notes added for further research work:

- 1) Sample M = Random sample from grocery store commercially grown with NPK fertilizer.
- 2) Sample F1= Spinach grown with organic manure prepared from cowdung.
- 3) Sample F4= Spinach grown with nutritional soil correction (remineralization) + biomagnetic treatment of water + cowdung manure. This has resulted in nutritionally enriched spinach with nutritional levels well above the standard textbook nutritional levels given by USDA.

Observation:

Spinach grown using the principles of Nutritional Farming (soil remineralization + biomagnetics) had almost double the amount of iron, calcium and magnesium compared to commercially available spinach grown using NPK fertilizer.
